Commissioner Murphy made a motion to raise the response call pay for fire/ems calls from \$15 to \$20 a call. Commissioner Margeson seconded the motion. The motion passed. The increase to \$20 per call will be retroactive, starting April 1, 2022. This will be Resolution 455.
