## February 8, 2021

Commissioner Margeson called the **Regular Fire Commissioners** meeting to order at 7:03 pm.

Because of COVID-19, the February 8, 2021 meeting was conducted virtually.

The **minutes of January 11, 2020** were unanimously approved.

Commissioner Murphy made a motion to include an executive session in the regular meeting. Chairman Margeson seconded the motion.

<u>Treasurer's Report</u>: Beginning January Operating Fund cash balance was \$81,362.02. Beginning January General Investment Fund balance was \$12,032.43. Beginning January Capital Fund cash balance was \$102,844.83. The beginning January Capital Investment Fund balance was \$33,993.29. Grand total is \$230,232.57.

January expenses were \$896.05. Payroll for January was \$2,946.07, and VFF stipends were \$1,505.00. The grand total of expenditures in January was \$5,347.12.

January revenue included \$22.42 in taxes collected, \$400.00 in donations, \$1.51 in interest, and \$0.51 in IGT Increases. Total January revenue was \$424.44.

<u>District 17 Commissioners reviewed and approved the Treasurer's Report, invoices, and firefighter stipends at their February 8, 2021 public meeting. Commissioner Murphy made a motion to accept the Treasurer's Report, and Commissioner Margeson seconded; motion was approved unanimously.</u>
