Commissioner Margeson called the **Regular Fire Commissioners** meeting to order at 7:00 pm.

The minutes of September 13, 2021 were unanimously approved.

<u>Treasurer's Report</u>: Beginning September Operating Fund cash balance was \$39,171.10; beginning September General Investment Fund Balance was \$12,040.97; beginning September Capital Fund cash balance was \$136,644.83; beginning September Capital Investment Fund balance was \$34,017.43; grand total is \$221,874.33.

September expenses were \$4,955.93. September payroll was \$3,303.07. September VFF stipends were \$1,685.00. Grand total of \$8,259.00 for September expenditures.
